Dear Sir/Madam,

With reference to the regulation of Bapepam Number X.K.1 re Disclosure of Information That Must Be Made Public Immediately and Number X.M.1 re Disclosure of Information of Certain Shareholders, herewith we would like to inform you as follows:

1. On 6 September 2006, PT Astra International Tbk (the "Company") acquired 1,002,835,949 shares of PT Bank Permata Tbk ("Permata") at a price of IDR875 per share from the Republic of Indonesia, represented by the State-owned Asset Management Agency (PPA).
2. The acquisition increased the share ownership of the Company in Permata from 2,443,250,061 shares (or 31.55% of share capital of Permata) to 3,446,086,010 shares (or 44.50% of share capital of Permata).
3. The acquisition of additional shares would strengthen the Company's participation, and together with Standard Chartered Bank (SCB) help Permata's management to achieve its objectives of developing the brand in the Indonesian consumer and SME sectors.
4. The acquisition was carried out together with the Company's joint-venture partner, SCB, who also took up an equal numbers of shares as taken up by the Company.
