### ANNOUNCEMENT PURSUANT TO RULE 704(17)(b) OF THE LISTING MANUAL OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED (THE “LISTING MANUAL”)

The Board of Directors (the “**Board**”) of Jardine Cycle & Carriage Limited (“**JC&C**” or the “**Company**”) refers to:

- (i) its announcement dated 13 November 2017 (the “**13 November Announcement**”) relating to its acquisition of the Relevant Interest in Vietnam Dairy Products Joint Stock Company (“**Vinamilk**”); and
- (ii) its announcement dated 16 November 2017 relating to its acquisition of additional Vinamilk Shares through on-market purchases.

Capitalised terms used but not otherwise defined herein shall have the same meanings given to them in the 13 November Announcement.

The Board wishes to announce that Platinum Victory Pte. Ltd., a wholly-owned subsidiary of the Company, has acquired 12,824,994 additional Vinamilk Shares, representing approximately 0.9 per cent. of the issued share capital of Vinamilk, by way of on-market purchases (such acquisition, the “**Acquisition**”). Following the Acquisition, the Company has an aggregate interest in approximately 8.9 per cent. of the issued share capital of Vinamilk, comprising 129,125,368 Vinamilk Shares.

Pursuant to Rule 704(17)(b) of the Listing Manual, the aggregate cost of the JC&C group’s quoted investments before and after the Acquisition is as follows:
